J. Gregory Connors is the President and Chief Executive Officer for the Saratoga Economic Development Corporation (SEDC). As a life-long Saratoga County resident, Greg has established experience and professional credentials in both the private and public sectors, specifically, economic development, government relations, real estate sales and community service.

For 11 years, Greg served as a member of the senior leadership team at GlobalFoundries in the Office of Government Relations, responsible for state, regional and local government interaction and regulatory affairs in both New York and Vermont. Dereth Glance is the Director for Region 7 for the New York State Department of Environmental Conservation, which includes the Central New York counties of Oswego, Onondaga, Madison, Cayuga, Cortland, Chenango, Tompkins, Broome, and Tioga. Dereth joined NYSDEC as Deputy Commissioner for Environmental Remediation and Material Management in January 2022. Formerly, Dereth served as the Executive Director for Onondaga County Resource Recovery Agency (OCRRA) and was appointed to the NYS Climate Action Council Waste Emissions Advisory Panel. Prior to that, Dereth was appointed by President Obama to serve as a U.S. Commissioner at the International Joint Commission (IJC) charged with preventing and resolving disputes and promoting cooperation for the shared waters of the United States and Canada. Previously, she served as the Executive Program Director of Citizens Campaign for the Environment (CCE), directing water, energy, and waste reduction programs for five regional offices in New York and Connecticut. Dereth also chaired the Citizen Participation Working Group for the Onondaga Lake Bottom Subsite of the Onondaga Lake Superfund Site, chaired the OCRRA recycling committee, and has served on New York State's Great Lakes Basin Advisory Council, the Clean Water Network and the Onondaga Lake Partnership Outreach Committee. She graduated from James Madison College of Public Affairs at Michigan State University with a degree in Political Theory and Constitutional Democracy.
